Defining Objectives and Scope

***Good objectives help make sure you are
solving the right problem***

They are essential in order to

- Select an appropriate VA approach
- Identify necessary information
- Make decisions during the VA process
- Get the VA results used

VA objectives vs. conservation objectives

- VA objectives inform *the focus and scope of the assessment*
- VA can help in evaluation/identification of conservation goals and objectives

Setting goals and objectives for a VA

- What *problems* are you addressing?
- What *decisions* need to be supported?
- What do you ultimately want to *achieve*?



A few steps to help identify objectives

1. Write down all the concerns you hope to address after the VA is complete
 - What would be nice to know?
 - What's most important to know?
2. Translate concerns into succinct objectives

Translating concerns into objectives

1. Use directional language when possible

Concern: I want to do a vulnerability assessment for my park, but I'm worried it'll be really expensive.

Possible objectives:

- Maximize the extent assessed within park boundary
- Minimize cost of assessment

Translating concerns into objectives

2. Avoid objectives with ambiguous direction

Concern: I'm worried that I'll put a lot of effort into an assessment that never gets used.

Possible objective:

- Optimize the assessment to inform management decisions

Translating concerns into objectives

2. Avoid objectives with ambiguous direction

Concern: I'm worried that I'll put a lot of effort into an assessment that never gets used.

Possible objective:

- Optimize the assessment to inform management decisions
- Maximize engagement of targeted assessment users

Tips for writing good objectives

- Be clear:
 - What you want
 - When you want it
 - How you'd know (measure success)
- Focus on fundamental objectives more than how you'll achieve them

Getting to Fundamental Objectives

WITI – Why Is That Important?

When your answer is:

- *“Just because (it is an essential area of concern)”*
- *“It’s the law”*
- *“This is important”*
- *“Inherent value”*

You have reached a fundamental objective.

- Why? **More exposure = more vulnerability and increased need for mgmt**
 - *Why manage and monitor?*

My objective is to acquire downscaled climate change projections for My Fabulous National Park


- Why? More exposure = more species response and increased need for mgmt
 - *Why manage and monitor?*
- **Because NPS is obliged to "conserve the scenery...and the wild life therein" (NPS Organic Act)**
 - **FUNDAMENTAL OBJECTIVE**

The objective of my CCVA is to understand the relative vulnerability of the species in my refuge to climate change.

My objective in performing a vulnerability assessment is to prioritize restoration projects.

My fundamental objective is to maximize the likelihood that the Ozark hellbender will be de-listed. I will do a CCVA to minimize the risk of selecting management measures that are highly vulnerable to climate change.
